

Snow Removal Contract

Terms and Conditions

1. Extent of Work

Snow Blowing and Shoveling Includes:

- Snow blowing where applicable
- Snow shoveling where snow blowing isn't practical or the area isn't accessible

De-Icing Includes:

- Evaluation of temperature and ice conditions
- Proper application of appropriate products in appropriate locations based on evaluations
- Note: we never use harmful products

Snow Removal Includes:

- Loading the snow onto trucks and hauling it away

After the start of the service, the client understands unexpected costs might change the price (including, but not limited to: unforeseen challenges, obstacles, obstructions, etc.), the client may receive additional charges.

[Snow removal business name] promises to only use high-quality products for the service, including, but limited to: poly snow plows, professional grade snow blowers, and high-quality salt sprayers.

Even though the [snow removal business name] will seek to avoid any property damage, no promises can be made. Any damages caused by [snow removal business name] will be covered by [insurance provider name].

All essential labor, materials, tools, and equipment are included in the agreed upon price.

2. Service

The estimate is an approximate price and might vary from the actual total price of the service.

At any time, [snow removal business name] has the right to reject any property it deems unsafe.

[Snow removal business name] reserves the right to capture photographs and/or videos of the client's property for marketing and/or media use.

The client understands they're required to provide free access to the areas needing snow removal (e.g. driveway, sidewalk, etc.).

The client agrees to remove all obstacles, obstructions, and valuables away from the site of service. Any damages to these items are at the client's expense.

3. Guarantee

[Snow removal business name] promises a 100% satisfaction guarantee on all snow removal services. If the client is not 100% satisfied, [snow removal business] will return to the property free of charge.

5. Contract Pricing

The client agrees to pay [snow removal business name] a total of \$_____ dollars per visit for all labor and materials listed within the contract, which is subject to additions and/or deductions occurring in accordance with unpredictable changes and/or authorized requests for changes.

5. Completion Dates

[Snow removal business name] defines a snow event as two inches or more of accumulated snow and/or ice. [Snow removal business name] strives to remove all snow and ice from the property within 24 hours of the minimum two-inch accumulation. Although, severe snow events may delay the time of service.

6. Payments

All contract payments will be auto-paid using the credit card on file on the day of every snow event service, and an invoice will be emailed. No cash or check payments will be accepted. Payments will begin on the first day of service of a snow event.

If the payment is declined or late, then [snow removal business name] has the power to consider failure of pay as a breach of contract, deny service, and take legal action and/or terminate this contract. Any disputes or chargebacks to the credit card company will incur a fee of \$_____ dollars.

In addition, late payments are subject to loss of discounts as well as a late penalty of \$_____ dollars per day.

7. Legal Compliance
